EXHIBITOR SHOW TERMS AND CONTRACT MARCH 31 2012

1. Exhibitor will comply with all City, County, and State laws and are solely responsible for all taxes.
2. Chris Garbee, Roanoke Valley Comicon employees or Salem Civic Center are not responsible for any loss, damages, claims, or injury
3. Each application will be processed on a first come first serve basis.
4. Exhibitor shall keep all designated areas clean and will not nail, screw or attach anything to the Exhibit Room. Exhibitor is responsible for any damage they cause..
5. Exhibitor agrees that all merchandise for sale is legal and licensed (“bootleg”). Exhibitors selling “bootleg” material may be ejected without refund.
6. All pornographic material must be pre-approved and remain behind tables.
7. Subletting is not permitted.
8. All displays, chairs, tables and merchandise must be maintained within Exhibitor’s designated area.
9. Any disruptive behavior, in the judgment of the Sponsor, by the Exhibitor, its agents, employees or representatives shall result in expulsion from the show.
10. Drinking of any alcoholic beverages is prohibited.
11. Roanoke Valley Comicon is a non-smoking show within exhibit room or directly outside exhibit room.
12. Exhibitor is responsible to provide its own insurance, if desirable, to protect Exhibitor and Exhibitor’s property from damage, loss, theft, harm or injury. Neither sponsor nor the Host Facility will obtain insurance on Exhibitor’s behalf. Exhibitor is solely responsible for its own exhibit material, goods, samples and other property.
13. Exhibitor will hold harmless the Sponsor and Host Facility, or any of their respective officers, agents, employees, representatives or affiliates, from any liability, damage, loss, harm, claim or injury to property or person or the Exhibitor, Exhibitor’s officers, agents, employees or other persons, whether caused by the negligence of the Sponsor or Host Facility, or from theft, fire, water, accident, or any other cause whatsoever.
14. Exhibitor agrees to protect, keep, and save Roanoke Valley Comicon (Untamed Worlds, and Chris Garbee), the promoter of the event, forever harmless from any damage(s) or charge(s) imposed for violations of any ordinance or regulation by the Exhibitor, his employees or agents, as well as failure to comply with the terms and agreements of this contract. Further, Exhibitors shall at all times protect, indemnify, save , and keep harmless Roanoke Valley Comicon (Untamed Worlds, and Chris Garbee) against and from any loss, cost, damage, liability, or expense which arises out of or from or by reason of any act or omission of the Exhibitor, his employees, or agents.

In the event that the Salem Civic Center or any part of the exhibit area thereof is unavailable, whether for the entire event or a portion of the event, as a result of fire, flood, tempest, or another such cause, or as a result of governmental intervention, malicious damage, acts of war, strike, labor disputes, riot, or agency which RVC/UW/CG is necessary to cancel, postpone, or re-site the show, or reduce installation time, exhibit time, or move out time, RCV/UW/CG shall not be liable to indemnify or reimburse the Exhibitor in respect of any damage or loss, direct or indirect, arising as a result thereof.
16. Exhibitor agrees to remain set up during all open hours of the convention.. No early breakdown is allowed without consent of RVC.
17. \$35.00 service charge on all returned checks.
18. If Exhibitor fails to comply with above rules - Chris Garbee or Roanoke Valley Comicon can terminate this agreement.
19. RVC/UW/CG shall have full power in the interpretation and enforcement of all contract regulations contained herein, and the power to make such amendments thereto, and such further rules and regulations as shall be considered necessary and proper.
20. The foregoing represents the agreement between the undersigned Exhibitor and Untamed Worlds/ Chris Garbee, the promoters of the Roanoke Valley Comicon, for the convention on March 31, 2012.
